ROAD MAINTENANCE AGREEMENT

Agreement No. 2024 - ____

BETWEEN:

The Rural Municipalities of Pleasantdale No. 398, Lake Lenore No. 399, Flett's Springs No. 429, and Kinistino No. 459 (hereinefter colled the "municipality")

(hereinafter called the "municipality")

- and -

(hereinafter called the "hauler")

WHEREAS the hauler wishes to use a municipal road for the purpose of transporting quantities of goods and materials that are significant in nature and the movement of which in the councils' opinions is likely to result in damage, the Councils of the municipalities require the hauler to enter into a Road Maintenance Agreement pursuant to Section 22 of *The Municipalities Act* and Part III of *The Municipalities Regulations*.

THE PARTIES AGREE AS FOLLOWS:

1. The municipality shall allow the hauler to haul product along the following roads:

Designated haul roads ONLY, as indicated on Appendix "A"

2. After the execution of the Road Maintenance Agreement, the hauler shall complete Schedule "A" within 15 days of completed season hauling, or by December 31, whichever is first AND shall pay IN FULL to the municipality as compensation for <u>road maintenance and capital road loss</u> based on verified quantities at a rate of:

- **3.** All vehicles shall use only the route mentioned in Section 1 above; and shall travel at a speed no greater than 60km/hr, whether the trailer is loaded or empty.
- 4. The municipality shall maintain the roads in a reasonable state of repair.
- 5. If severe road damage occurs which is directly attributable to the hauling operation, the municipality reserves the right to negotiate the costs of the damage with the hauler. If an agreement cannot be reached, an engineer from Saskatchewan Ministry of Highways and Infrastructure will be asked to assess the damage and his assessment shall be binding.
- 6. The hauler may haul weights in accordance with the seasonal weights as established by the Ministry of Highways and Infrastructure.
- 7. The Municipality reserves the right to stop the hauling operation during times of inclement weather, when in the opinion of Council or an appointed agent, severe road damage is likely to occur. The hauler shall contact the municipal offices prior to commencing any haul on a daily basis.
- 8. At the time of execution of the Road Maintenance Agreement, the hauler shall provide the municipality with the license number and description of all vehicles and trailers that will be hauling product in accordance with this Agreement, as per Schedule "B".
- 9. If the hauler breaches any part of this Agreement, the municipality reserves the right to cancel the Agreement.
- 10. This Agreement shall be valid until December 31 in the year of issue.


